

Conditions of participation for "Guess the Weight"

Participation in the "Guess the Weight" contest on the web page www.wirsindgüter.de/en/schwergewichteln or www.wirsindgueter.de, as part of the "Freight belongs on rail" campaign, is possible only under the terms and conditions specified herein. By participating in the contest, the participant accepts these terms and conditions of participation.

1. Organiser of the contest

Organiser of the contest is DB Cargo AG, Rheinstrasse 2, 55116 Mainz.

2. Eligibility and exclusion from participation

Any natural person who has reached the age of 18 and who has a permanent residence in Germany at the time of participation is eligible to participate.

If a participant has limited legal capacity, participation requires the consent of a legal representative.

Employees of DB Cargo AG - Department L.CVM 1 (Marketing), Deutsche Bahn AG - Department GNM 32 and GNM 22 (Marketing) and Department GNE 3 (Communication), DB Systel GmbH - sub-team Web Experience, Web Development, AT Verbund, as well as service providers commissioned in connection with the contest are excluded from participation.

In addition, the organiser reserves the right to exclude persons from participation if there are justified reasons for doing so. Justified reasons include (a) interference with access to or implementation of the contest, (b) breaches of these conditions of participation, (c) dishonest practices or (d) false or misleading information in connection with participation in the contest.

3. Period of participation

Participation is possible during the Guess the Weight contest period from 8:00 am on 6 December 2021 to 11:59 pm on 26 December 2021, exclusively during the three time slots

listed below:

- 8:00 am on 6 December 2021 until 7:59 am on 13 December 2021, Central European Time (CET).
- 8:00 am on 13 December 2021 until 7:59 am on 20 December 2021, Central European Time (CET).
- 8:00 am on 20 December 2021 until 7:59 pm on 27 December 2021, Central European Time (CET).

4. Participation

Participation in the contest is only possible within the three time slots specified in section 3.

Participants can enter the contest during all three time slots for a first-time or repeat chance to win. Participation in the contest is free of charge.

After clicking on the "Submit an estimate" button, participants are taken to the registration form where they must also enter their first and last name and e-mail address. These fields are required.

Participation in the contest is then activated by clicking on the "Take part now" button at the end of the registration form after ticking the checkbox indicating consent to participation and to the privacy statement.

5. Prizes awarded

The following prizes will be awarded among all winning participants at the end of each contest period:

Contest from 6 December 2021 to 13 December 2021: ten Vanmoof e-bikes

Contest from 13 December 2021 to 20 December 2021: ten 75" Samsung "The Frame" TV sets

Contest from 20 December 2021 to 27 December 2021: ten 14" MacBook Pros

Winners are responsible for payment of any tax on their prize.

6. Awarding the prizes

The ten participants whose estimate is closest to the correct response will be declared the winners. If more than ten participants submit a correct estimate, the winners will be drawn at random from the pool of participants with correct estimates.

Eligible participants are those who have entered exactly one estimate and have provided the mandatory information set out in section 4 in full and accepted these terms and conditions of participation. The prizes for each time slot will be awarded immediately after the end of the respective time slot (see section 3).

7. Time and method of notification of the winner

The winners of the respective time slot will receive a prize notification which is to be sent to the e-mail address on file no later than 30 January 2022. In the case of prizes to be delivered by post, the winner then has seven days to respond to the prize notification and provide a postal address for shipment. If a winner does not submit an address within seven days of the prize notification being sent, the prize will be forfeited.

Prizes will be dispatched by no later than 31 March 2022. The prize will be forfeit if delivery of the prize fails for the second time for reasons relating to the winner himself or herself. The winner will then no longer be eligible to claim the prize. The prize is non-transferable, and cash or exchange is not available. Prizes are non-exchangeable and non-refundable.
